



NOTICE OF SWIMMING POOL POLICIES, PROCEDURES & RULES

Opens Memorial Day Weekend
OPEN...Tuesday - Sunday | 6:00 A.M to 10:00 P.M.
CLOSED...Monday for maintenance

Members, Family and Guests are requested to cooperate in observing these policies and procedures and to obey the instructions of CCIA Staff. Policies, Procedures and Rules are subject to change as CCIA deems necessary.

GATE ENTRY: Members may enter the pool area by using their gate key then by signing the daily register. There will be CCIA staff periodically (not a lifeguard) on duty during pool operating hours to check register, monitor activities, and enforce rules.

POOL PASS: A Pool Pass will be issued to Members in good standing (dues paid) and signing **RELEASE FORM**. Member or Family Member must present a pool pass to staff upon request when entering pool area. If you do not have a pool pass, you will not be allowed to enter.

1. **RELEASE FORM:** All Members must complete the Release Form before using the pool facility.
2. **DAILY REGISTER:** All Members, Family and Guests are required to sign-in using the Daily Register once entering the pool area.
3. **MEMBER:** A Member is defined as a property owner of a Single-Family Residence, Duplex, Business or Vacant Lot in the Crown Colony Community Development and is registered in the CCIA Property Owners Data Base.
4. **FAMILY MEMBER:** A Member Family is defined as those living at home up to two (2) adults and their children, or dependents; that are single, still in school, 21 years and under. Also, grandchildren under the age of 18.
5. **GUESTS:** A Guest is defined as anyone who is not a Family Member as described above. Each Member is allowed up to four (4) Guests.

6. **RENTER:** A renter of property in Crown Colony is not considered a Member, under the CCIA Bylaws, and therefore must have Property Owner complete a Letter of Authorization in addition to the Release Form.
7. **NON-SWIMMER UNDER 12 YEARS OF AGE:** May NOT enter the pool alone but MUST always be accompanied by the Member or his/her approved responsible adult guardian and who can swim. However, the Member DELEGATING this responsibility to another adult guardian remains solely responsible for their actions and welfare while in the pool area and by signing the Release Form releases the Crown Colony Improvement Association of all liability.
8. **LEGAL AGE TO ENTER & SWIM IN POOL ALONE:** Children must be 12 years of age and a swimmer to enter the pool unaccompanied by an adult.
9. **“SWIM AT YOU OWN RISK”:** No lifeguard will be on duty.
10. **POOL PARTIES:** Organized children’s pool parties are allowed provided the host Member makes a reservation with a CCIA Staff in advance of party. Up to eight (8) children will be allowed as party guests of host Member. Host Member will be responsible for the conduct of their party guests and clean-up.
11. **SWIM WEAR:** Appropriate swimwear must always be worn both in and out of pool. Additionally, it must be worn as intended, to not expose private body parts as children are present in pool area.

POOL RULES

Pool rules are intended to benefit all users to assure a safe and enjoyable experience. CCIA Staff will firmly, fairly, and consistently enforce pool rules. Anyone violating swimming rules are subject to the revocation of their swimming privileges. Swimming is permitted only during pool hours.

1. No lifeguard on duty. “Swim at your own risk”
2. Pool Hours Posted at pool. OPEN...Tuesday – Sunday
CLOSED...Monday (except Memorial Day & Labor Day).
3. A Member Pool Pass is required to enter the pool area.
4. Children under 12 years of age must always be accompanied by a responsible adult.

5. All Guests must be sponsored and accompanied by a registered Member.
 6. Gate will be double locked when pool is closed.
 7. No Smoking, alcoholic beverages, illegal substances or weapons are allowed.
 8. No diving or flipping.
 9. No glass containers allowed.
 10. No pets allowed.
 11. No running, rough-housing or aggressive behavior.
 12. No profane language allowed.

SWIMMING POOL PASS RULES

Members

- Only one (1) Pool Pass will be granted per Member.
- A pool pass must be presented to CCIA Staff when requested to gain access to swimming pool. No Pool Pass...No access.
- All persons entering the pool area must sign register before entering the swimming pool.
- Any Family Member living in the Member's Crown Colony home, over the age of 12 and under the age of 21, (see Pool Policies, Procedures and Rules) may use the Pool Pass to gain access to the Swimming pool.
- A Family Member under the age of 12 cannot use a Pool Pass to gain access to swimming pool.
- Guest(s) must be accompanied by a Member or Family Member.
- Grandchildren under the age of 18, not living in Member's home, must be accompanied by the Member or a Family Member. A Pool Pass cannot be used by a grandchild. However, they do not count as a guest when accompanying a Member.
- A Pool Pass will not be granted if Property Owner has not paid HOA dues.
- Parents of children attending a scheduled pool party are not allowed to swim. They can enter the pool area with the party host Member for purposes of supervising their child.

Renters

- Only one (1) Pool Pass will be granted to an Authorized Rental property lessee (Letter of Authorization signed by Property Owner).
- A pool pass must be presented to Gate Attendant to gain access to swimming pool. No Pool Pass...No access.
- All persons entering the pool area must register before entering the swimming pool.
- Renters will not be allowed to have guests.
- Renters will not be allowed to host pool parties.
- Only Renters family living in rental property over the age of 12 and under the age of 21, (see Pool Policies, Procedures and Rules) may use the Pool Pass to gain access to the swimming pool.
- A Pool Pass will not be granted to Renter if Property Owner has not paid HOA dues.
