




Sources of Income - \$263,117






Operating Expense - \$247,356





Swimming Pool Usage




- Trended downward

2021 Initiatives and Improvements

- Landscape renovation to Temple Blvd. entry flower beds, removed pampas grass, added ornamental trees, shrubs, flowing plants, and sod.
- Repaired damaged brick column and gate at Temple Blvd. entry paid by insurance company
- Replaced over 100 landscaping plants (mainly Indian hawthorns) and trees killed by the February freeze.
- Replaced all lawn irrigation system backflow valves to meet City code requirements.
- Continued to add/updated HOA database to include email addresses to make communication with members more efficient.
- Continued sending "Welcome to the neighborhood" emails to all new residents and renters.
- Continued "Please Slow Down" sign (green) initiative.
- Upgraded security camera internet upload speed to 100 GB
- Worked with DENWARA to add recently platted lots on Champions Dr into the HOA.



2022 Initiatives

- Revise Covenants and Restrictions and Bylaws to meet Senate Bill 1588 requirements for HOAs.
- Add flag night spotlights to old fountain flags.
- Updates and refresh HOA website
- Repair old and add new landscape lighting at main entrance.
- Continue to encourage delinquent members to settle overdue accounts.



Future Improvements Under Consideration

- Key Fob Access Control System on swimming pool entry gate.
- Resurface Tennis Courts and net post replacement.
- Digital Radar Speed Sign on Champions Drive.
- Playground for children in recreation common area.
- New HOA Office.
